

Online Tax Payment

1. Click on the Outagamie County Property Search link on the Grand Chute website or provided here: <https://ascent.outagamie.org/LandRecords>
2. At the Outagamie County Land Records site, either type in your parcel number, with no spaces or dashes, or type in your street number along with the corresponding street name (when typing in the street name do not use directional or street suffix— i.e. W Seneca Dr, just type in Seneca in the street name field). Then click Find Now.


- At the bottom of the screen you will see a link that says Pay Taxes. Click on that, and proceed to select the amount you would like to pay and click Pay.
