FINAL ELECTION IN 2016



I'm certain you have all heard some interesting media coverage regarding Wisconsin's Photo ID.

In July 2016, Federal District Judge Lynn Adelman issued an order requiring the Wisconsin Elections Commission to implement an affidavit option for voters unable to obtain an acceptable Photo ID with reasonable effort. On August 10, 2016, the Seventh Circuit Court of Appeals issued an order staying the decision of Federal District Judge Lynn Adelman. The stay order means that while the appeal to the Seventh Circuit Court of Appeals is pending, the "affidavit option" will not be in effect for any future elections. The Wisconsin Elections Commission will be monitoring this closely. For now, there is no change to the Photo ID law. Stay tuned to local news media and the Town's website for updates.

The General Election will be held on November 8, 2016. Polls will be open from 7:00 a.m. to 8:00 p.m. at all four polling locations. There are important election dates regarding registration and absentee voting. They are as follows:

- * 09/22/16 - Absentee ballots will be mailed to registered voters with requests on file
- * 10/11/16 - Last day to establish residency to vote in Grand Chute (electors moving after this date must vote at their previous polling location)
- * 10/19/16 - Last day to register by mail (must be postmarked no later than this date)
- * 10/20/16 - Registration is only available in-person at the Clerk's office until November 4
- * 10/24/16 - Absentee voting in the Clerk's office begins
- * 11/03/16 - Last day to request an absentee ballot by mail
- * 11/04/16 - Last day to register to vote in the Clerk's office
- * 11/04/16 - Last day to vote in the Clerk's office
- * 11/08/16 - Election Day

Voter Registration

You may register to vote by mail, online at <https://myvote.wi.gov>, at the Clerk's office, or at your polling location on Election Day. With any of these options, you will need to provide proof of residency. The acceptable proofs of residency are listed on the

backside of the voter registration application or you can find the list on the Town's website at www.grandchute.net under Quick Links, Elections tab. Register early to avoid long lines on Election Day. It is important to note if you have moved, recently changed your name, or are a new resident of Wisconsin, you will need to register or re-register.

Absentee Voting

Senate Bill 324 limits the times for in-person absentee voting to between the hours of 8 a.m. and 7 p.m. Town Hall is open from 8:00 a.m. to 4:00 p.m. for in-person absentee voting, Monday through Friday, except the last

Thursday and Friday before the election, when Town Hall is open until 5:00 p.m. In-person absentee voting is prohibited on weekends and holidays.

With each General Election, in-person absentee voting is conducted in the Town Hall Board Room. I will have several election inspectors available to assist you, and I encourage you to take advantage of absentee voting to avoid long lines that are typical for November elections.

Election Inspectors

We asked for additional election inspectors and many answered the call. I am pleased to inform you that

we have 12 new inspectors. All election inspectors are mandated to attend training prior to each election and are provided with the latest, updated materials to review prior to Election Day.

When you visit the polls, please take a moment to thank our inspectors. They work very long hours and do a fantastic job for our community.

Thank you, and we appreciate your dedication not only to Grand Chute, but to the electoral process.

DOG LICENSES



The State of Wisconsin requires that all dogs receive rabies vaccinations by a veterinarian and are licensed by their local municipality. As a

reminder, the licensing year is January 1 – December 31, and licenses for 2017 will be available the second week in December of 2016.

The Town of Grand Chute requires licenses for dogs over five months of age, and new residents must license their dog within 30 days. The license fee is \$11.00 unless spayed or neutered, then the fee is \$6.00. There is no fee for licensing dogs used to assist the blind, deaf, or mobility impaired, and a license will be provided upon application.

Dog licenses may be obtained by mail or at the Administration window at the Grand Chute Town Hall. Whether applying in person or by mail, a rabies vaccination certificate must be presented (this is a document you receive from your veterinarian, not your invoice for the service), along with proof of sterilization (this may be noted on the vaccination certificate as well).

NOTE: We are required to see the rabies certificate each year you apply for a license. (a copy of the certificate is not kept on file at the Town Hall)

When sending an application by mail (application is available on the Town's website under Finance) include: completed application, rabies vaccination certificate, proof of sterilization, the

appropriate payment, and a self-addressed stamped envelope. Once your license has been processed, your certificate and new license will be mailed back in the envelope you provide.

The maximum number of animals per household is six; the maximum number of dogs is three, the maximum number of rabbits is two, with the exception of a litter of kittens or pups which may be kept for a period of time not to exceed five months from birth. Although cats and ferrets are required to receive rabies vaccinations, the Town does not require these pets to be licensed.

Kennel licenses may be available for owners wishing to exceed the maximum number of three dogs. A Special Exception Permit application shall be filed with Community Development (application available on the Town's website under Find a Form) for review and consideration.



TAXES

December is quickly approaching, and with that comes 2016 tax bills. Grand Chute's tax bills will be mailed by Outagamie County before the 3rd Monday in December, and the first installment payment is due to the Town of Grand Chute by January 31, 2017.

As a taxpayer, you have the option of paying your tax bill in full, or in two installments. Should you choose to pay your taxes in two installments, the first installment is due to the Town of Grand Chute by January 31, 2017, and the second is due to Outagamie County by July 31, 2017.

NOTE: Failure to pay any installment in full by the specified due date, will result in the full tax bill becoming due, and interest and penalties will be assessed.

WINTER PARKING ON ROADWAY

Between November 1st and April 1st of the following year, parking of vehicles on any road or street in Grand Chute for more than 30 minutes is prohibited between the hours of 2:00 a.m. and 6:00 a.m.

These parking regulations allow for proper snow removal from the roadway to make driving safe for all motorists. Reasonable requests to the Grand Chute Police Department to allow for vehicles to remain on the roadway during these times will be permitted if a snow emergency has not been declared. In the event a snow emergency is declared, absolutely no requests will be granted and vehicles in violation will be removed from the roadway at the owner's expense. Winter parking violations can result in parking citations of \$20 per incident.

SCHOOL DAY TRAFFIC SAFETY

We hope everyone has had a safe and enjoyable summer! With the start of the school year upon us, we want to share some safety reminders with everyone.

- 1) Obey the signs on the roadway such as 5-minute loading zones, 15-minute waiting areas, no parking zones, etc.
- 2) The speed limit is 15 MPH when children are present - A child can jump out into the roadway at any moment so slow down and pay attention.
- 3) The area around the schools gets very congested at the beginning and end of the school day - give yourself a few extra minutes to pass through these areas safely.
- 4) Watch for and obey crossing guards' signs and signals. They are there for everyone's safety.
- 5) Do not block a crosswalk at a red light or when waiting to make a turn.
- 6) Never pass a stopped school bus that is loading or unloading children.
- 7) When passing a bicyclist, be sure there are at least three feet between them and your vehicle.
- 8) Watch for bicyclists coming from driveways or behind parked cars.

We hope these reminders help keep everyone safe when traveling to and from school this fall. We look forward to seeing all the new and returning parents and kids this school year!



HUNTING IN GRAND CHUTE: THINGS TO KNOW

In Grand Chute, we have a great rural portion of land to complement our busy commercial district. With the northern part of the Town prime for hunting, there are a few things to remember before climbing into a tree stand.

- * Hunters must have permission from land owners prior to hunting.
- * Hunters must be 50 feet from any roadway and 100 yards from any building before discharging a weapon.
- * Only bow and crossbow hunting is permitted in the areas of the Town south of Capitol Drive and I41 and east of Mayflower Drive. The use of other weapons is prohibited.
- * Shotgun, muzzleloader, and bow/crossbow hunting is permitted in the area of the Town north of Capitol Drive and I41 and east of Mayflower Drive.

Any violations of the above regulations will result in municipal citations and/or criminal charges for unlawful discharge of a weapon. As always, be safe this hunting season and remember:

- * Treat every firearm as if it is loaded.
- * Always point the muzzle in a safe direction.
- * Be certain of your target and what's beyond it.
- * Keep your finger outside the trigger guard until ready to shoot.

WATCH OUT FOR DEER – FALL DRIVING SAFETY INFO

The fall season increases deer activity and car vs. deer crashes. Car/deer crashes can occur at any time throughout the day, but drivers need to be extra cautious during early morning and dusk hours of travel. These times are the most active deer movement periods. If you are involved in a crash with a deer, report it to law enforcement if you need an insurance report. Wis. Stat. § 29.349 now allows for possession and removal of a deer carcass from the scene of a car/deer crash once an individual notifies the DNR by calling 608-267-7691 and provides their name, address, and

the carcass location. This notification must be completed before taking possession or removing the carcass from the scene. Car/deer kills are no longer required to be tagged by a law enforcement officer, meaning the use of DNR-issued car/deer kill tags have been discontinued.



NATIONAL CHILD PASSENGER SAFETY WEEK ~ SEPTEMBER 18TH – 24TH

In the United States, motor vehicle crashes are a leading cause of death among children, age 3 to 14 years. Reduce the risk of death or serious injury by making sure child passengers are buckled in age- and size-appropriate car seats, booster seats, or seat belts. The safest place for children is properly buckled in the back seat.

As part of National Child Passenger Safety Week, drivers with child passengers are encouraged to visit a child safety seat inspection station to have a certified technician inspect their car seat and receive hands-on advice and guidance. In Outagamie County, call Nurse Direct to schedule an appointment (920-738-2230).

Key Recommendations:

- * Every transition decreases protection. Delay transition as long as possible.

Safest Practice

Birth - 12 months
Always ride in a rear-facing car seat, in the back seat.

***Age 1 - 3 years**
Rear-facing in back seat, as long as possible, within the height or weight limit allowed by car seat manufacturer. Then front-facing car seat in back seat.

Age 4 - 7 years
Front-facing car seat used within the height or weight limit allowed by the car seat manufacturer. Then a booster seat using lap and shoulder seat belt in the back seat.

Age 8 - 12 years
Booster seat until seat belt fits properly with lap belt snug across the upper thighs, not the stomach and shoulder belt snug across the chest, not across the neck/face. Keep children in the back seat until age 13.

*American Academy of Pediatrics (AAP) recommends a rear-facing car seat until 2 years of age or until they reach the highest height or weight allowed by the car seat manufacturer.

- * All children under 13 years of age should be properly restrained in the back seat. Airbags can kill children riding in the front seat.
- * NEVER place a rear-facing car seat in front of an airbag.
- * Check the seat's owner's manual and labels on the seat for weight and height limits.
- * Install and use car seats and booster seats according to the seat's owner's manual.
- * Do not use car seats after the manufacturer's expiration date.
- * Do not buy or use previously-owned or secondhand seats; you need to know the history of the seat and be notified directly if there is a recall notice.
- * Read the vehicle owner's manual on how and where to properly install the car seat using the seat belt or LATCH system.
- * Set a good example by always using your seat belt.

CONSTRUCTION UPDATE



Grand Chute continues to see strong construction activity throughout the community. Through July 2016, both the number of permits issued and the total value of all construction projects has nearly kept pace with the record-setting levels attained in 2015. Permits have been issued for 11 new commercial buildings, 70 commercial remodel/addition projects, 44 new homes, and 85 residential remodel/addition projects. The total construction value of all permits issued to date is \$50 million. For the 4th year in a row, we are on pace to record over 60 housing starts. With new subdivisions opening up in the Lynndale Drive and Elsner Road areas, we expect continued growth in new homes over the next few years.

OVERFLOW GARBAGE WEEK

A separate truck will follow to pick up the overflow garbage during your garbage day or possibly the next day. Please note that overflow garbage does not include appliances, TV's, building material, or any hazardous material. This is the final overflow garbage week of the year.

2016 FREE TIRE COLLECTION

September 19-23

Residential properties are allowed to place up to four (4) tires at the end of their driveway by 7 a.m., Monday the 19th. Tires must be 18" or less, rims are acceptable. You must call (920) 832-1581 or email us at publicworks@grandchute.net by September 18th to be placed on the list. We need your address, phone number, and the number of tires.



HYDRANT FLUSHING

During September and October, between the hours of 7:30 a.m. and 4:30 p.m., our crews will be flushing the main water distribution lines through the fire hydrants. The program must be performed to supply you with quality drinking water. You may detect discoloration from mineral deposits in your water pipes. Using your cold water fixtures at more frequent intervals should help correct the problem. Although the water may appear to have a somewhat unpleasant characteristic, it is completely harmless. Thank you for your cooperation.



UTILITY TAX ROLL CHARGES

All unpaid water, sewer and storm charges (for services provided prior to October 1, 2016) will be subject to a 10% penalty if payment is not received before November 1, 2016. All delinquent payments must be in our office before November 15, 2016 to eliminate tax roll placement. Notices to landlords, owners, and tenants will be mailed by October 15th.

SNOW PLOWING

Town crews typically do most of the snow plowing during the night hours, so please keep this in mind when placing your trash and recycling items out the night before pick-up.



Please remember when plowing parking lots or long driveways that depositing snow on Town right-of-ways is prohibited. This blocks vision and can cause damage to Town equipment once the pile freezes. It is also against Town Ordinances to blow or shovel snow from your driveway into the street. Either of these violations could result in a citation.

SIDEWALKS AND SNOW

Per Town Ordinance, if your property is on a street that has sidewalks, you, as the property owner, are responsible to clear that snow and/or ice within 24 hours from the time the snow ceases to accumulate on sidewalk.

TRAIL SYSTEM

Snow and ice are not removed from all trails within the Town. The most used connections are kept clear of snow. At times, the trails are confused with sidewalks. Typically a trail is 8' to 10' wide and a sidewalk is 5' wide.

2016 BRUSH CHIPPING SERVICE & YARD WASTE SITES

The Town will offer brush chipping only in the months of May, June, September, and October. The chipping volume of 480 cf will remain the same and the scheduled pick up day, which is always a Tuesday, will remain the same based on your refuse collection. (See below for the dates.)




HALLOWEEN SAFETY TIPS FROM YOUR GRAND CHUTE FIREFIGHTERS

Halloween is a time of year that the children in our community look forward to. As trick-or-treaters start making their rounds, don't be surprised when you see a fire engine in the neighborhood. Each year, your Grand Chute Firefighters take to the streets on Halloween to ensure the safety of these costumed, candy-seekers while also handing out a few treats along the way. In addition to our proactive presence, we offer the following tips to ensure everyone enjoys a safe and happy Halloween:

- * When choosing a costume, stay away from long-trailing fabric. If your child is wearing a mask, make sure the eye-holes are large enough so they can see out.
- * Provide children with flashlights to carry as lighting or glow-sticks as part of their costume.
- * Dried flowers, cornstalks and crepe paper catch fire easily. Keep all decorations away from open flames and other heat sources.
- * Use a battery-operated candle or glow-stick in jack-o-lanterns as opposed to a candle.
- * Remember to keep exits clear of decorations, so nothing blocks escape routes.
- * Make sure all smoke alarms in the home are working.
- * Tell children to stay away from open flames including any jack-o-lanterns which may have candles in them. Be sure they know how to STOP, DROP AND ROLL if their clothing catches on fire.
