RESOLUTION TO APPROVE & EXECUTE A RELOCATION ORDER TO
ACQUIRE PROPERTY FOR STORM WATER DETENTION BASIN.

WHEREAS, the Department of Public Works has determined the necessity for surface water and storm water drainage facilities on the property and is recommending the acquisition of a portion of Lot 2 of Outagamie County Certified Survey Map No. 3696, more particularly described in the attached.

NOW, THEREFORE, BE IT RESOLVED by the Sanitary District #3 of the Town of Grand Chute that the Sanitary District determines that it is necessary and a public purpose for Sanitary District #3 to acquire a portion of the Lot 2 described in the attached for said purpose of construction of a storm water detention basin.

BE IT FURTHER RESOLVED by the Sanitary District #3 that this resolution constitutes a Relocation Order for acquisition of property described in the attached in accordance with the title acquisition procedures set forth in Wisconsin Statutes, Section 32.02(1) and 32.05, and said property being a portion of Lot 2 of Outagamie County Certified Survey Map No. 3696.

BE IT FURTHER RESOLVED that the proper Sanitary District officials are hereby authorized and directed to execute any and all documents necessary for implementation of this order and that a certified copy of this Resolution shall be filed with the Outagamie County Clerk within twenty (20) days of its adoption.


BE IT FURTHER RESOLVED that this Resolution shall be effective immediately upon its passage and publication.

Description of termini of project:
