### New Construction/Additions/Alterations

	Industrial/Warehouse:	75% of commercial rate on same square feet
	Non-Residential Farm Building:	100% of commercial rate on same square feet

### Remodeling/Alteration (when unable to determine square footage)

Project cost up to \$5,000:	\$20 + \$10/\$1,000
Project cost over \$5,000:	\$70 + \$ 5/\$1,000 over \$5,000

### Electrical, Heating, Ventilating, Air Conditioning

Project cost up to \$500:	\$30
Project cost of \$501 - \$1,000:	\$30 + \$ 5/\$100 cost, or fraction thereof over \$500
Project cost of \$1,001 - \$10,000:	\$55 + \$12/\$1,000 cost, or fraction thereof over \$1,000
Project cost of \$10,001 - \$100,000:	\$163+ \$ 3/\$1,000 cost, or fraction thereof over \$10,000
Project cost over \$100,001:	\$433+ \$ 1/\$1,000 cost, or fraction thereof over \$100,000

### Electrical Service Change

100/200 Amp:	\$30
Over 200 Amp:	\$50

### Plumbing (Minimum permit fee is \$30)

New or Replacement Sanitary Sewer Lateral, Storm Sewer Lateral or Water Service:	\$10/inch of pipe diameter (Minimum fee = \$30 each)
New fixture or water connected appliance:	\$7/fixture or appliance
Repair, re-pipe, building drain, sewer cap:	\$30

Parking Lot only: \$150

Commercial Site Erosion Control Inspections: Contracted inspection cost + 5%

### Drainage Facilities Check (See Note #2)

Building size less than 20,000 sq. ft.:	\$600
Building size 20,001 to 50,000 sq. ft.:	\$1,000
Building size 50,001 to 100,000 sq. ft.:	\$1,500
Building size greater than 100,000 sq. ft.:	\$2,000
Staff Approvals with no Contracted Services	\$200

### Sprinkler System

New Construction:	\$70 + \$22 per riser or floor
Alterations to Existing Systems:	\$25

### Certificate of Occupancy

Commercial/Business (New or Changed):	\$150
Apartments:	\$150 + \$10/dwelling unit

**Note # 2:** Any re-inspections of sites violating the approved drainage plan will be charged a fee equal to the actual contracted inspection cost + 5%.

Structural Addition/Alteration to a Commercial Building:	\$200

Single Family:	\$319 (See Note #3)
Duplex or Multi-Family:	\$244/dwelling unit
Non-Residential:	\$1.57/\$1,000 of construction value

<b>Park Development Fees</b>

Single Family:	\$400
Duplex:	\$600
Multi-Family:	\$200/Unit

**Note # 3:** Fee is waived for any new single family residential structure of a size <1,500 square feet of living area.
